### Overview of de minimis value regimes open to express shipments worldwide

De minimis refers to the minimum value of the goods below which no duties and taxes are being collected by the Customs (see also Transitional Standard 4.13 of the WCO Revised Kyoto Convention). Certain countries have a separate threshold below which simplified declarations are accepted, e.g. in form of the transport manifest or other suitable form.
